1.0 Introduction

Le présent document produit par le Centre canadien de lutte contre l'alcoolisme et les toxicomanies (CCLAT) centralise la littérature grise et examinée par des pairs qui présente ou analyse les études sur le fonctionnement et l'incidence des sites d'injection supervisée¹. La bibliographie originale a été créée en utilisant des variations du terme « établissements d'injection » et ciblait les sites canadien et australien avec les expressions « Insite » pour Vancouver et « centre d'injection sous surveillance médicale » pour Sydney. Elle a ensuite été enrichie avec les documents recommandés par des chercheurs du domaine et l'examen de listes de référence.

Le CCLAT surveillera régulièrement la littérature grise et examinée par des pairs pour y repérer de nouvelles publications pertinentes, qu'il ajoutera alors au document.
